Supports	All non-text navigation and functional elements are accompanied by text descriptions. Additionally, when a user submits non-text content (e.g., respondent file upload), alternative text is provided.
(b) Equivalent alternatives for any multimedia presentation shall be synchronized with the presentation.	Supports	If a survey designer user uploads a video or image to be contained in a survey, they enter alt text for it in the box provided via the interface. Otherwise there is no multimedia in the core app (n/a)
(c) Web pages shall be designed so that all information conveyed with color is also available without color, for example from context or markup. (e) Redundant text links shall be provided for each active region of a server-side image map.	Supports	No server-side image maps are used. However, if a survey designer user adds an image map to a survey there is a box requiring them to enter alt text for each area in the map
(f) Client-side image maps shall be provided instead of server-side image maps except where the regions cannot be defined with an available geometric shape.	Not applicable	No client-side image maps are used.
(g) Row and column headers shall be identified for data tables.	Supports	All row and column headers are text based.
(h) Markup shall be used to associate data cells and header cells for data tables that have two or more logical levels of row or column headers.	Supports	Header rows are indicated in the markup.
